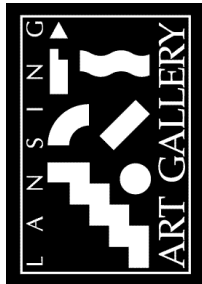

Art as Social Discourse

For over a century, artists have been questioning the structures of society. This has included challenges to class, gender, race, and violence. We are now asking Michigan artists to create art that deals with the concerns of our time at the individual, community, national and global levels. Ask questions, and seek answers with your art.

Entry Procedure

A maximum of three entries per artist may be submitted. Entries will be juried by digital JPEG. (**\$15 for up to three entries**)

CD's will not be returned. Entries must be postmarked by April 11, 2008. (**Additional entry forms may be downloaded from www.lansingartgallery.com.**)

Eligibility

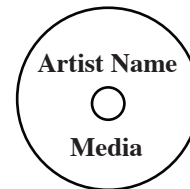
1. Social Discourse is open to Michigan artists 18 years or older.
2. Artists may enter up to three works of any media.
3. Artist must assume responsibility of delivery to second level exhibition space.
4. Works must have been executed within the last two years.
5. Artwork entered should not be so fragile that public display is potentially harmful to the work or viewer.
6. Artwork must be properly prepared and presented.

Conditions

Lansing Art Gallery reserves the right to remove a work for any reason. Lansing Art Gallery will charge 50% commission on sales. If a sale is made, the artist must provide their social security number. Entries will be handled with all possible care, but Lansing Art Gallery is not responsible for loss or damage from any cause whatsoever. Artist must provide their insurance. Permission to photograph accepted work for publicity purposes shall be understood to be granted unless specifically denied.

Digital Entry

Digital files must be submitted on a CD. The digital image should be a minimum of 504 pixels in either a vertical or horizontal format, with a 72 dpi resolution, in JPEG format. Images should be in color. Each CD must be labeled with artist's name and media using a permanent marker. **No paper labels please.**
